HOW TO TRANSFER OWNERSHIP OF AN AMERICAN PAINT HORSE

Alterations on the transfer report are not acceptable. Any erasure or alteration of a transfer form may necessitate verification and/or a new transfer, properly completed and signed. Be certain that the photograph on the front of this certificate matches the horse being purchased. If the markings do not match, PROCEED WITH CAUTION and contact APHA.

Name changes: If a member's last name has changed and the member wants their horses to be owned in their new last name, the transfer report should be completed listing the new name as "buyer." The date of sale should be listed as either the date of marriage, date of divorce, or date of original purchase, whichever is more current. The fee is \$2.50 member/\$27.50 non-member.

Membership requirements: The buyer listed on the transfer form must have a current membership in the same exact name or a non-member fee will be charged. Memberships in individual names will not suffice for joint or partnership ownerships.

Transfer fee:

\$15 Member rate (if you have a current year membership in the exact same name as the buyer listed)
 \$40 Non-member rate - includes membership. If you do not have a membership with APHA, you may purchase a membership at this time and take advantage of member rates on this transaction and any other transactions postmarked during the membership period.
